

Jimmy Beshai was a 17-year employee for the West Boylston Water District serving from 1980 to 1997. He held the position of assistant superintendent during his tenure at the District. Jimmy oversaw several projects involving the expansion, maintenance, and improvement of West Boylston's water system along with maintaining the District's water system and facilities. Jimmy visited the Water District office on many occasions, during his retirement years, to check in with the District staff and get an update. On several occasions he also helped with the meter reading even after his retirement.

Mr. Beshai was the son of Italian Immigrants and was born and became a lifelong resident of West Boylston. He served proudly in the Naval Reserves during the Korean War. Jimmy ran his own successful landscaping business before coming to work for the District, he was well known for keeping a very meticulous and beautiful lawn and garden around his home and took great pride in his landscaping capabilities. Jimmy was well known within the Town and the Water District as well as with the VFW. Jimmy will be missed dearly by many of us here, at both the District and within the Town of West Boylston.

To the District Clerk of the West Boylston Water District of West Boylston, Massachusetts, in the County of Worcester,

GREETINGS:

In the name of the Commonwealth of Massachusetts you are directed to notify the inhabitants of the West Boylston Water District of West Boylston, qualified to vote in elections and District affairs, to meet at the West Boylston Water District, 183 Worcester Street, West Boylston, in such District, on Monday the third (3rd) day of June in the year of 2019 at 7:00 o'clock in the evening, then and there to act on the following articles:

ARTICLE 1: To elect the following District Officers:

- (A) Moderator for one year(B) District clerk for one year
- ARTICLE 2: To hear the report of the officers of the District and to act thereon.
- ARTICLE 3: To see if the District will vote to transfer from any unexpended balances from the Fiscal Year 2019 appropriations or other available funds to Fiscal Year 2020 appropriation accounts, or take any action in relation thereto.
- ARTICLE 4: To see if the District will vote to raise and appropriate a sum of money for the District's maintenance and operating expenses budget for Fiscal Year 2020, beginning July 1, 2019 and ending June 30, 2020, or take any action relative thereto.

ARTICLE 5: To see if the District will vote to authorize the District Treasurer, with approval of the Board of Water Commissioners, to borrow money from time to time in anticipation of the revenue of Fiscal Year 2020, beginning July 1, 2019 and ending June 30, 2020, in accordance with General Laws Chapter 44, Section 4, as amended, and to issue a note or notes as may be given for a period of less than one year in accordance with General Laws Chapter 44, Section 17as amended, or any other authority available to the District, and to authorize the District Treasurer to enter into a compensating balance agreement or agreements for Fiscal Year 2020 pursuant to General Laws Chapter 44, Section 53F, or take any action relative thereto.

ARTICLE 6: To see if the District will vote, that a sum of money be appropriated for the purpose of financing the construction of the North Main Street Water Main project; including all appurtenances. Including without limitation all costs thereof as defined in Section 1 of Chapter 29C of the General Laws, as most recently amended by St. 1998, c.78; that to meet this appropriation the Treasurer with the approval of the Board of Water Commissioners is authorized to borrow a sum of money and issue bonds or notes therefore under (Chapter 44 of the General Laws or other applicable general or special law governing the issuance of local bonds) and/or Chapter 29C of the General Laws, as most recently amended by St. 1998, c.78; that such bonds or notes shall be general obligations of the District unless the Treasurer with the approval of the Board of Water Commissioners determines that they should be issued as limited obligations and may be secured by local system revenues as defined in Section 1 of Chapter 29C, as most recently amended by St. 1998, c.78; that the Treasurer with the approval of the Board of Water Commissioners is authorized to borrow all or a portion of such amount from the Massachusetts Water Pollution Abatement Trust established pursuant to Chapter 29C, as most recently amended by St. 1998, c.78; and in connection therewith to enter into a loan agreement and/or security agreement with the Trust and otherwise to contract with the Trust and the Department of Environmental Protection with respect to such loan and for any federal or state aid available for the project or for the financing thereof; that the Board of Water Commissioners are authorized to enter into a project regulatory agreement with the Department of Environmental Protection, to expend all funds available for the project and to take any other action necessary to carry out the project, or take any action relative thereto.

Report of the Water Commissioners To the Citizens of The West Boylston Water District 2019

In Compliance with the laws establishing the West Boylston Water District, the Board of Water Commissioners hereby submits its 80th Annual Report.

At the annual Town Election, held on June 4, 2019, candidates James LaMountain and Gary Flynn were elected for three-year terms. The following results were posted:

At the Annual Meeting of the District, held on June 3, 2019, Mr. David J. Sweetman was nominated and elected to a one-year term as moderator. In addition, Mr. Robert Bryngelson was nominated and elected to the position of District Clerk.

As chairman of the West Boylston Water District Commission, it gives me great pleasure to provide the District Members with the Annual Report for 2019. The West Boylston Water District continues to make significant progress in its goal to provide you with the best quality of water at the most reasonable price. The Commission voted a twenty percent water rate increase in 2019 to finance much needed capital improvements to the water system. District expenses continue to rise as water system upgrades are needed on a regular basis due to the age of the system.

The District continues to focus on tightening of operating expenses while meeting its mandatory schedules for major system maintenance such as the cleaning and repairing storage reservoirs, distribution system upgrades and the upgrading of our pumping facilities. We are continuing our effort to explore potential new sources of water and/or water treatment options for the District through ongoing meetings with our Legislators, the Department of Conservation and Recreation, and the Department of Environmental Protection. The District appreciates the continuing efforts made by Senator Harriet Chandler and Representative James O'Day for their assistance in coordinating meetings with the State Agencies.

The District has made significant progress in our efforts to update our water system and provide the ratepayers with the best water quality possible. I would like to direct you to the Superintendent's report for a more detailed description on the water system.

In closing, on behalf of the Board of Water Commissioners I would like to extend our deepest gratitude to the Superintendent, Michael Coveney, and our staff, for the continued outstanding support they provide to the District and our citizens. I would also like to thank my fellow members of the board of water commissioners for their commitment to the District.

SUPERINTENDENTS REPORT TO THE DISTRICT 2019

Members of the West Boylston Water District, I hereby submit to you my sixteenth annual report as Superintendent. I have had the pleasure of working for the District for nineteen years now, starting as a water operator in 2001 and becoming Superintendent in 2004. This brief report will reflect some of the issues the District has experienced through the Year of 2019.

The District continues to grow with existing developments slowly expanding over the last year including Westland Circle Extension and a few new single and double family homes in town. We also supervised the installation of a new fire services for both the Light Dept and the Next Level Church on Crescent St and a new service to the Girl Scouts building on Century Drive.

The water consumption of the District has remained consistent with our need to stay below our registered withdrawal limit. Congratulations to those of you who have been conserving, keep up the good work as it really does take some of the burden away from the system. Our MassDEP registered withdrawal limit is 0.56 MGD (Million Gallons per Day) and the amount pumped for 2019 was just over the allowed limit at 0.58 MGD. We still need to maintain the mandatory lawn watering restrictions to try to stay within these limits.

The Oakdale Well and Pleasant Valley Well have elevated levels of Manganese. This element that has been occurring naturally within the ground is one of the top priority concerns of the District. We have been controlling the use of these wells to reduce the amount of manganese that is pumped into the water system. We received and signed an administrative consent order (ACO) from MassDEP to reduce the levels of Manganese in the water system, as there are concerns with the health effects of consuming too much manganese. We are working with our consultant on a conceptual design for a water treatment facility to determine the best way to remove the Manganese from the water at the Oakdale Well. The District has also been actively pursuing a new source of water at the Pleasant Valley Well. Both projects will undoubtedly cause an increase in the water rates in the coming years, but this seems to be the only viable solution at this time.

The District has found a new source well to be located near the existing Pleasant Valley Well. We have been able to install a test well and have had very favorable results with both the water quality and quantity at this location. Special Legislation was passed at the State House in 2018 to allow the District to modify the existing easement to incorporate the new well. We are currently working with the DCR, MassDEP and our Legislators to finalize this process.

We have an ongoing capital improvement program for the many aging water services and fire hydrants that could be up to 70 or more years old. There were 14 water services that were replaced in 2019 from the main to the property line of the customer. I encourage every resident to familiarize themselves with their water service and find out if it needs to be replaced by contacting us to obtain the records for your service that are on file. We also replaced three fire hydrants in 2019 with newer traffic style models that are designed to break without causing a major leak if they become damaged. The underground water tank on Lawrence St was temporarily removed from service in 2019 for a thorough cleaning and inspection. The 1940's era tank was drained and inspected by our consultants. It was determined that this tank will need some significant upgrades to meet the current industry standards but the concrete structure is still very solid and will likely provide many more years of service to the District by performing the upgrades needed to return this tank to service. New access hatches will need to be installed along with a thorough cleaning and coating. This work will save the District a significant amount of money over the cost of a new tank.

Our crew was very busy in 2019 as there were six major water main breaks; 81 Franklin St, 173 Lancaster St., Woodland St. at Pierce St, 6 Maplewood Ave., 220 Maple St. and 8 Maplewood Ave. Six service breaks were repaired also. We are currently evaluating the breaks and looking into replacing water mains in the areas of the system where the breaks are becoming more frequent. The District has an ongoing capital improvement plan with our consulting engineer to identify the areas in the system that need to be upgraded.

The District has been working with our consultants on the design of a new water main for North Main Street and the surrounding area in Oakdale. The existing water main has experienced numerous breaks over the years. The District has been awarded a state revolving fund (SRF) loan from the Massachusetts Clean Water Trust, this includes a low interest loan and partial grant from the State to help pay for this important project. It was voted by the District at the 2019 Annual Meeting to move forward with this project and authorize the District to accept the SRF funding. This project is scheduled to be put out to bid in early 2020 and started as soon as possible.

The District has launched a newly designed website in 2018 which is more user friendly for our residents and to our office staff to be able to post new updates. It is always accessible for information and I encourage you to take a look at <u>www.westboylstonwater.org</u> for any questions that you may have. We also have a Facebook page in order to keep residents informed of any service issues. I also encourage residents to sign up for the CodeRED customer notification system that will notify you of any important issues.

The District has and will continue to provide a consistent high-quality service to its members. We maintain three (3) wells, four (4) storage tanks, over 56 miles of pipeline ranging from a ³/₄ inch service up to a 16" transmission main, over 400 fire hydrants, close to 1,000 main valves and over 2600 water meters. The daily staff consists of a Superintendent, Operations Supervisor, Water Operators, and an Administrative Assistant.

In conclusion I wish to thank our District Staff consisting of Robert Lopez, Joseph Carlson, David Castagnetti, Lori Renzoni and Anthony DiPietro. They have been a pleasure to work with and I commend them for their loyalty, dedication and professionalism. I also wish to thank the District Treasurer Heather Isaacs and the Board of Commissioners both past and present for their guidance. And mostly I want to thank you, the members of the District, for your patience, understanding and support.

- Repair leaking faucets and toilets! If you faucet is dripping at the rate of one drop per second, you can waste 2,700 gallons per year.
- Replace your old toilet, the largest water user inside your home. The new water saving toilets use just 1.6 gallons per flush.
- Use your dishwasher and clothes washer only when you have a full load. And make sure the water level is correct for each load.
- Your clothes washer is the second largest water user in the home. Many new Energy Star rated washers also have a Water Factor at or lower than 9.5. They use 35% -50% less water and 50% less energy per load.
- Take short showers rather than baths, using a low-flow showerhead of course.
- Install low-flow faucets and fixtures.
- Don't use running water to thaw meat or other frozen foods. Defrost food overnight in the refrigerator on by using the defrost setting of your microwave.
- Insulate your water pipes. You'll get hot water faster and won't waste water while it heats up.
- Store drinking water in the refrigerator. Don't let the tap run while you're waiting for cool water to flow.
- Turn off the faucet while you shave, brush your teeth or hand-wash dishes.

Saving Water Outdoors

- If you water your lawn, only do so when absolutely necessary. Lawns need only one inch of water per week from all sources. So, if there has been an inch of rain during the week, you don't need to water.
- Use mulch around trees and shrubs and in your garden beds.
- For landscaping, use native plants or those that use less water. Check with the local nursery for your best choices.
- Use an inexpensive rain gauge to measure how much rain or irrigation your yard has received.
- Adjust your sprinkler to water only your lawn and plants not the sidewalk, house or street. Don't water on windy days or in the middle of the day, to reduce the amount of water lost to evaporation.
- Use shut-off nozzles on hoses and automatic shut-off devices on irrigation systems.
- Limit your pesticide and fertilizer use. They will eventually find their way into the water supply.
